Indexation	After the Initial Term and after each Renewal Term, TrustBuilder shall have the right to increase the Fees due under the Agreement by using the following formula: P = P0 x [0.2 + 0.8 x (S/S0)], whereby: "P" stands for the revised price; "P0" stands for the price on the Effective Date; "S0" shall be the national average reference salary as published by Agoria ("Reference Salary") on the Effective Date (or, if this index is no longer published, the index replacing it or failing such index by another index reflecting the increases of labour cost); "S" shall be the Reference Salary at the time of the price revision; and "S/S0" shall be referred to as "Index". A negative Index shall have no impact on the Fees. The base Index taken is the Index applicable three (3) months before the signing of the first Order Form.
